A resolution by the Williamson County Republican Party honoring the service of 100% disabled veterans residing in the Great State of Tennessee

WHEREAS, Governor Bill Lee issued Executive Order 102, on July 03, 2023, and

WHEREAS, Governor Bill Lee's stated purposes of the Executive Order 102 is "to make Tennessee the best state in the country for service members, veterans, and their families to live, work, and prosper," and

WHEREAS, Tennessee is working diligently toward that goal on the state, regional, and local level, and

WHEREAS, Tennessee's 100% disabled veterans are presently entitled to a property tax exemption of up to \$175,000 per year, and

WHEREAS, while generous when originally passed by the Legislature and signed into law by a former Governor, the exemption no longer achieves the intent of the Legislature and Governor, and

WHEREAS, with the dramatic increase in residential, assessed property values, the property tax exemption should be increased by 100% in the Legislative Session beginning in January 2025, and

NOW, therefore, the Williamson County Republican Party Subcommittee on Veteran & Military Affairs and the Williamson County Republican Party Chairman and Leadership, respectively, request that the Legislature remedy this discrepancy and honor the gallant and distinguished service of those service members whose service to our Nation has rendered them 100% disabled by the U.S. Department of Veterans Affairs.
